



**Supplemental Collaboration Agreement Pursuant to Sections 22A to 22C, 23, and 23A to 23I of the Police Act 1996 (as amended by the Policing and Crime Act 2009 and the Police Reform and Social Responsibility Act 2011)**

**THIS SUPPLEMENTAL AGREEMENT** is made on 24 December 2012

**BETWEEN**

1. Chief Constable of Avon and Somerset Constabulary; and
2. Chief Constable of Wiltshire Police; and
3. the Police and Crime Commissioner for Avon and Somerset; and
4. the Police and Crime Commissioner for Wiltshire.

**IT IS AGREED**

**1. INTRODUCTION**

- 1.1 By an agreement dated 31 December 2010 made between Avon and Somerset Police Authority, CCAS, CCWP, and Wiltshire Police Authority ('the Principal Agreement') the they agreed to collaborate over the establishment of the MCIT.
- 1.2 By virtue of the provisions of Schedule 15 Police Reform and Social Responsibility Act 2011 the respective Police and Crime Commissioners are successors in title to the respective Police Authorities and together with CCAS and CCWP are now the Parties to the Principal Agreement.
- 1.2 This agreement is supplemental to the Principal Agreement.
- 1.3 The Parties have agreed to vary the Principal Agreement as set out in this Supplemental Agreement.

**2. DEFINITIONS**

In this Supplemental Agreement:

<b>"Act"</b>	means the Police Act 1996 (as amended by the Policing and Crime Act 2009 and the Police Reform and Social Responsibility Act 2011);
<b>"CCAS"</b>	means the Chief Constable of Avon and Somerset Constabulary ;
<b>"CCWP"</b>	means the Chief Constable of Wiltshire Police
<b>"MCIT "</b>	means Major Crime Investigation Team ;
<b>"PCCAS"</b>	means the Police and Crime Commissioner for Avon and Somerset
<b>"PCCW"</b>	Means the Police and Crime Commissioner for Wiltshire
<b>"Parties"</b>	means CCAS, PCCAS, PCCWS and CCWP and <b>"Party"</b> shall be construed accordingly;
<b>"Principal Agreement"</b>	means the agreement dated 31 December 2010 made between Avon and Somerset Police Authority, CCAS, CCWP, and Wiltshire Police Authority
<b>"Supplemental Agreement"</b>	means this supplemental agreement

**3. VARIATION**

The Parties agree:

- 3.1 The following clauses will be substituted for clauses 1.3 to 1.6 of the Principal Agreement:

1.3 This Agreement is made between the Parties pursuant to Sections 22A to 22C, 23, and 23A to 23I of the Act.

1.4 For the purposes of Section 23(5) of the Act, the Chief Constables have determined that the making of this Agreement is in the interests of the efficiency or effectiveness of their respective forces.

1.5 For the purposes of Section 23A(5) of the Act, the Police and Crime Commissioners have determined that the making of this Agreement is in the interests of the efficiency or effectiveness the forces they maintain.

1.6 For the purposes of Section 22A of the Act this Agreement contains a force collaboration provision and a policing body and force collaboration provision'.

3.2 The following clauses will be inserted as clauses 12.1.6, 12.1.7, and 12.1.8 of the Agreement:

'12.1.6 Subject to clause 12.1.7 of this Agreement for the purposes of the force collaboration provision contained in this Agreement the Chief Constables confirm that the holders of the civilian employee posts listed in Appendix F to this Agreement are designated under section 38B of the Police Reform Act 2002 with the authority to discharge the functions listed in section 38 of the Police Reform Act 2002 (as amended) in connection with the provision of the Service for the police forces participating in the collaboration the subject of this Agreement.

12.1.7 The designation under clause 12.1.6 of this Agreement of the holders of the civilian employee posts listed in Appendix F to this Agreement is subject to:

12.1.7.1 The holder of a civilian employee post listed in Appendix F to this Agreement having the same relevant designation under section 38 of the Police Reform Act 2002 in the police force which employs him or her;

12.1.7.2 The reporting of the holders of civilian employee posts listed in Appendix F to this Agreement and the functions under section 38 of the Police Reform Act 2002 they are to exercise to the Brunel Management Board.



12.1.8 The Parties agree that the holders of the civilian employee posts listed in Appendix E to this Agreement and the functions under section 38 of the Police Reform Act 2002 they are to exercise for the purposes of the collaboration the subject of this Agreement may be varied by the Brunel Management Board'.



3.3 The Appendix to this report will be inserted as Appendix F to the Principal Agreement.
